# PERSONAL INCOME TAX PROJECTION ENGAGEMENT LETTER

This letter confirms and specifies our understanding concerning the tax projection services that Roberts Accounting CPAs, P.C. (the "Company") will perform for you, the taxpayer, (as representative of both you and your spouse, if applicable.) By signing this engagement letter and/or sending us the information for the preparation of your income tax projection(s), you and all parties referenced in this letter are agreeing to the terms of our engagement.

# **Tax Projection Service**

The Company will prepare your Federal and/or State income tax projection(s) for all jurisdictions that you are required to file in based on your specific request and stated purpose for the projection(s). We will use our best judgments and abilities when preparing your tax projection(s).

Roberts Accounting CPAs, P.C. is not required to audit the information that you provided to us as it relates to your projection(s). Therefore, it is your responsibility to make sure that the information that you provide is true and accurate to the best of your abilities.

As the preparer of your tax projection(s), the Company understands that you have the right and freedom to consider other professional tax and accounting services, should ours not suit your needs. However, if you choose to take your business elsewhere, please be aware that the Company holds the right to bill you for all services that have been rendered on your behalf.

The Company's fees for tax projection(s) preparation are based on the time required for all work performed, the complexity of any technical issues addressed, the need to confirm information or to perform accounting work as a precondition to preparing your projection(s), and the timely receipt of all essential information. Work performed in relation to this engagement will be invoiced upon the reasonable completion of your tax projection(s) and will be due to the Company upon your receipt of the invoice.

# Your Responsibility to Provide Information

In order to properly and most accurately prepare your tax projection(s), it will be necessary for you to provide us with all general, financial and income tax information that we request. We will provide you with a questionnaire, and/or other request forms. These forms will list all pertinent documentation and information needed for the preparation of your projection(s). Please respond to these requests completely and in a timely manner. If for any reason you are unable to provide us with all pertinent tax information and documentation it may result in incomplete and/or inaccurate tax projection(s). If we are unable to complete your tax projection(s) due to not receiving the documentation required from you to accurately complete them, the time spent on the projection will still be billed and due.

### Your Copy of Your Tax Projection(s)

We will provide you with a copy of your income tax projection(s) either electronically or by paper.

# **Estimated Taxes**

Federal and State law requires taxpayers to make estimated tax payments as they relate to the taxpayer's tax liability for the current year. Failure to make sufficient estimated tax payments to the IRS or the state(s) to which you reside, may result in assessed tax penalties. When we send you your completed tax projection(s), we may also provide you with a recommended schedule of Federal and/or State tax estimated payments. There is no guarantee that this estimated payment schedule will in fact prevent you from being assessed for underpayment tax penalties. If, after completing your tax projection(s), we find that you have a tax liability to one or more taxing authorities, we will assist you by providing you with information on how you may make these payments. It will be *your* responsibility however, to make sure that all amounts due are paid to the taxing authority.
